



EX PARTE ORDER

UPON THE EX PARTE APPLICATION of the Applicant; AND UPON reading the Affidavits of Alan Wood filed August 5, 2016 and November 9, 2016 and the Affidavit of Service of Michelle Pyesmany filed November 9, 2016 and having reference to the Expert's Reports of Lisa Majeau Gordon filed August 5, 2016 and November 9, 2016; AND UPON hearing submissions of counsel for the Applicant; IT IS HEREBY ORDERED AND ADJUDGED AS FOLLOWS:

1. Service on the Respondents of the documents required to be served pursuant to paragraph 1 a of the Ex Parte Order filed August 15, 2016, is deemed good and sufficient.

2. The list of Respondents is amended as follows:
 - a. "Landing Rural Electrification Association" is removed; and
 - b. "Summer Village of South River" is changed to "Summer Village of South View".
3. The Applicant shall serve on each Respondent by email or registered mail the following documents as soon as practicable:
 - a. the Amended Originating Notice, filed November 8, 2016; and
 - b. this Ex Parte Order.
4. The Applicant shall post on the website www.ogilvIELaw.com/sections/alarie the following:
 - a. the Affidavits of Alan Wood;
 - b. the Affidavit of Service of Michelle Pysemany;
 - c. the Expert's Reports of Lisa Majeau Gordon;
 - d. the Amended Originating Notice; and
 - e. this Ex Parte Order.
5. Any Respondent opposing or seeking a variation of the proposed payment of expenses and distribution of assets set out in the proposed order which is Schedule "B" (revised) to the Amended Originating Application, shall notify the Applicant's counsel, Grant Dunlop, by email or fax on or before November 30, 2016 and shall provide the following on or before December 9, 2016 to Grant Dunlop, by email or fax:
 - a. the alternative order proposed by that Respondent, if any;
 - b. the alternative distribution calculation proposed by that Respondent, if any; and
 - c. the reasons for the objection and any alternative order or alternative calculation.
6. Any Respondent may apply for a variation of this Ex Parte Order on five days' notice to the Applicant. Notice to the other Respondents is not initially required, but may be directed on the hearing of any such variation application.
