Centre 10 Parkade

Precise Parklink | 517 10th Avenue SW | Parkedin Zone #1640

Walk: 6 minutes

Directions: Exit Centre 10 onto 10th Avenue SW. Walk to the right past Miele. Turn right onto 4th Street SW and walk south until you reach our building (look for Tim Hortons at the base).

Mon-Fri: \$6/hr, max \$19, early bird \$16, evening \$5

Type: Underground, pay-by-plate

Access: Back alley between 10th & 11th Ave SW, enter from 4th St or 5th St

7 parking levels — look for an unreserved spot (best availability on P1 or P5 to P7).

2 Vibe Outdoor Parking

Surface lot— access from 11th Avenue or the back alley |

Rate: \$7/hour

Walk: < 1 min to the left | Pay via QR code or text on-site

3 The Oliver Residences

524 10th Ave SW | Walk: ~7 minutes

Mon-Fri: \$8/hr, max \$27

Payment: Precise Parklink pay station in lobby

Directions: Exit onto 10th Avenue SW. Walk to the left cross at 4th Street SW and walk south until you reach our building (look for Tim Hortons at the base).

4 City Centre Parkade (CPA Lot 25)

340 10 Ave SW | Walk: 7 minutes | 1,530 stalls | Open 4:30 AM - 10 PM

Weekdays: \$4/half hr, max \$23

Payment: ParkPlus app or pay stations

Directions: Exit onto 10th Avenue SW. Walk to the left. Cross 4th Street and head south until you reach our building (look for Tim Hortons at the base).

5 Impark Lot 166

330 11th Ave SW | Walk: ~2 minutes

Payment: Impark hangTag app

Type: Surface lot | Open 24/7

Directions: Walk to the right cross 4th Street SW and you will reach our building (look for Tim Hortons at the base).
